

UNDERTAKING

1. I will not indulge in any behavior or act in that may be considered as ragging under clause 3 of the UGC Regulation on Curbing the Menace of Ragging in Higher Educational Institutions, 2009.
2. I will not participate in or propagate through any act of commission or omission that may be considered as ragging under the afore mentioned Regulation.
3. I am aware that DHSK College conducts Green Audit regularly and maintains its environment sensitively. I will not bring any Motor Vehicle (Two Wheeler or Four Wheeler) and will not use any kind of Plastic-polyphone inside the College Premises.
4. I am aware that use of Mobile Phone is prohibited during study hour.
5. I undertake that if I being outside the hostel without any permission from the hostel superintendent or college authority, if anything happens to me under those circumstances I shall solely responsible for that act and neither the college authority nor the hostel superintendent will not be responsible for such incidence.
6. I will participate in all the Co-curricular activities and Social Activities performed by the College/Hostel.
7. I will pay the hostel mess dues on time as fixed by the college authority/superintendent of the hostel.
8. I will ensure the presence of my parents in the parents meet/guardian meet organized by the college authority/hostel authority.
9. I will abide by the Rules and Regulations of the College as laid down by the authority and hereby undertake that I shall neither indulge myself nor instigate any other student(s) in such activities or create or instigate or compel others to cause or create nuisance in the College. I promise to maintain a healthy and good atmosphere in the College/Hostel premises. In case I am found to be involved in any act amounting to violation of discipline or misconduct, the college authority will have the right to rusticate me from the College Hostel.

10. I will not blame the college authority if I am not satisfied with the infrastructural facilities available in the hostel. If, I vacate the hostel seat at any point of time than I shall not claim the hostel admission fee and hostel caution money for refund.

11. I understand that for renewal admission I need to take a satisfactory recommendation from the Hostel Superintendent before taking hostel admission. If the recommendation from the Hostel Superintendent is not satisfactory than I will not be fit for renewal admission in DHSK College Hostel.

12. I will regularly visit the College Library during the break periods.

13. I will participate in the meetings or any programme organized by college/department and seat in a discipline manner.

14. I will abide by the Rules and Regulations of the College Hostel as laid down by the authority and hereby undertake that I shall neither indulge myself nor instigate any other student(s) in such activities or create or instigate or compel others to cause or create nuisance in the hostel. I promise to maintain a healthy and good atmosphere in the hostel premises. In case I am found to be involved in any act amounting to violation of discipline or misconduct, I will be rusticated from the College Hostel.

15. I undertake that I will participate in all social service activities within the hostel as well as college campus every Sunday, during holidays and outside the college campus under any programme (NCC & NSS). I will wake up before 5 am and enter the Hostel before 5 p.m. I will participate in Yoga and Sports activities regularly. I will vacate the hostel room if my regular class attendance is below 75% and also if I get 'back' in two semesters continuously. I must also compete in all the examinations organized by ICGPC of DHSK College.

16. I am aware that the entire College premise is under the CCTV surveillance.

17. I undertake that I shall not consume any kind of intoxicants viz. Pan, Gutkha, Alcohol, Cigarette etc. and will not spit here and there and in the toilet, inside the college premises and outside the college.

18. In case of any complaint I pledge to trust the College authority. In such situations, I will not use Social Media or any Electronic platforms against College authority. In case I am found to be involved in any act amounting to use the Social or Electronic Media against College Authority, the authority will have the

right to rusticate me from the college or to initiate necessary action whichever is dimmed fit for legal action.

19. Further, I promise that I shall come to the college in proper Hair Cut and Proper Uniform with Shoes prescribed by the college authority.

20. I undertake that the college authority will not be responsible for loss or damage of any of my property in the hostel. **Moreover I promise not to share ATM PIN Number, Internet Banking/Mobile Banking Pass Word/ E-mail. Id & Pass Word, and Mobile Pass Word to anyone.**

21. I undertake that I will not use any electronic gazettes like **Electric Kettle, Heater, Iron, Additional Charge Point, Hair straighteners etc.** in the hostel without permission.

22. After taking admission I shall not claim for refund the admission fee in any circumstances if, I leave DHSK College and take admission to any other educational institution. In case I am found involved in violation of the rules as mentioned above, I am liable for Legal Action.

23. **In case I would like to Contest the Students General Election I shall take a written permission from the Hostel Superintendent and Parents/Local Guardian before filing a nomination paper in the College.**

24. I shall abide by the rules and regulations as promulgated by the College Authority, Dibrugarh University, ASTU, UGC, Directorate of Higher Education, Govt. of Assam etc.
