

## UNDERTAKING (Hostel Boarder)

mission into College Hostel (for 01 year) of DHSK College (Autonomous).

1. I will not indulge in any act or behavior which may be considered as ragging under clause 3 of the UGC Regulation on Curbing the Menace of Ragging in Higher Educational Institutions, 2009.
2. I will not participate or propagate through any act that may be considered as ragging under the above mentioned Regulation.
3. I am aware that DHSK College (Autonomous) conducts Green Audit regularly and maintains its environment sensitively. I will not bring any Motor Vehicle (Two Wheeler or Four Wheeler) and will not use any kind of Plastic-polythene inside the College Premises. My Mobile phone will be kept in the custody of hostel authority after 6.00 pm.
4. I am aware that use of Mobile Phone is prohibited during study hours.
5. I undertake that if I remain outside the hostel without any permission from the Hostel Superintendent or college authority, if anything happens to me under those circumstances I shall solely responsible for that act and neither the college authority nor the Hostel Superintendent will not be responsible for such incidence.
6. I will participate in all the Co-curricular activities and Social Activities performed by the College/Hostel.
7. I will pay the hostel mess dues on time as fixed by the college authority/superintendent of the hostel. If fail to pay than appropriate action may be taken against me.
8. I will ensure the presence of my parents in the parents meet/guardian meet organized by the college authority/hostel authority.
9. I will abide by the Rules and Regulations of the College as laid down by the authority and hereby undertake that I shall neither indulge myself nor instigate any other student(s) in such activities or create or instigate or compel others to cause or create nuisance in the College. I promise to maintain a healthy and good atmosphere in the College/Hostel premises. In case I am found to be involved in any act amounting to violation of discipline or misconduct, the college authority will have the right to rusticate me from the College Hostel.
10. I will not blame the college authority, if I am not satisfied with the infrastructural facilities available in the hostel. If I feel so, I will vacate the hostel seat at any point of time than I shall not claim the hostel admission fee and hostel caution money for refund.
11. I understand that for renewal of admission I need to take a satisfactory recommendation from the Hostel Superintendent before taking hostel admission. If the recommendation from the Hostel Superintendent is not satisfactory than I will not be fit for renewal admission in DHSK College Hostel.

12. I will regularly visit the College Library during the break periods.
13. I will participate in the meetings or any programme organized by college/department in a disciplinary manner.
14. I will participate in the programme conduct by ICGPC of DHSK College (Autonomous) without fail.
15. I am aware that my seat in the Hostel will be continued if I pass all the examination within the year, if I get back any paper/course I will vacate the Hostel seat as a mandatory basis, otherwise appropriate action may be taken by Hostel authority.
16. I will abide by the Rules and Regulations of the College Hostel as laid down by the authority and hereby undertake that I shall neither indulge myself nor instigate any other student(s) in such activities or create or instigate or compel others to cause or create nuisance in the hostel. I promise to maintain a healthy and good atmosphere in the hostel premises. In case I am found to be involved in any act amounting to violation of discipline or misconduct, I will be rusticated from the College Hostel.
16. I undertake that I will participate in all social service activities within the hostel as well as college campus every Sunday, during holidays and outside the college campus under any programme (NCC & NSS). I will wake up before 5 am and enter the Hostel before 5 p.m. I will participate in Yoga and Sports activities regularly. I will vacate the hostel room if my regular class attendance is below 75% and also if I get 'back' in two semesters continuously.
17. I am aware that the entire College premise is under the CCTV surveillance.
18. I undertake that I shall not consume any kind of intoxicants viz. Pan, Gutkha, Alcohol, Cigarette, Chewing gum etc. and will not spit here and there and in the toilet, inside the college premises and outside the college.
19. In case of any complaint I pledge to trust the College authority. In such situations, I will not use Social Media or any Electronic platforms against College authority. In case I am found to be involved in any act amounting to use the Social or Electronic Media against College Authority, the authority will have the right to rusticate me from the college or to initiate necessary action whichever is dimmed fit for legal action.
20. Further, I promise that I shall come to the college in proper Hair Cut and Proper Uniform with Shoes prescribed by the college authority.
21. I undertake that the college authority will not be responsible for loss or damage of any of my property in the hostel. Moreover I am aware not to share ATM PIN Number, E-mail. Id, and Mobile Pass Word to anyone.
22. I undertake that I will not use any electronic gazettes like Electric Kettle, Heater, Iron, Additional Charge Point, Hair strengtheners etc. in the hostel without permission.
23. After taking admission I shall not claim for refund the admission fee in any circumstances if, I leave DHSK College and take admission to any other educational institution. In case I am found involved in violation of the rules as mentioned above, I am liable for Legal Action.
24. I shall abide by the rules and regulations as promulgated by the College Authority, Dibrugarh University, UGC, DHE, Govt. of Assam etc.

25. I am aware that I will be permitted to continue my seat as boarder of the hostel if I clear all examination in the year.
26. I pledge to uphold the dignity and respect of the teacher faculty at all times. I shall refrain from making any baseless motivated or defamatory allegation against any teacher. In the event of a genuine concern. I shall strictly follow the internal administrative procedures of the Grievance Redressal Cell of the college for resolution rather than discrediting the reputation of the teacher or the institution.
27. If any kind of allegation raised against me by any Boarder of the Hostel regarding Ragging/ Misconduct/Physical Assault/Indulgence of Any Illegal Activity/or any serious allegation then the College Authority will have full right to rusticate me from the Hostel without any question within 24 hours and will be liable for Legal Action.
28. I am aware that I will not be permitted to accommodate any guest in my room.
29. I do hereby solemnly swear that I shall never create any social media group involving the students of DHSK College (Autonomous), nor shall I join any such group. Even if I am added to such a group by someone else, I will withdraw myself immediately. If I am found creating or joining any such social media group, the college authority shall have the right to expel me from the institution, and I shall have no objection or complaint against such action.

In case of violation of this rule the College authority can process legal action against him.
